All chapters are eligible for consideration, regardless of the size or age of your Chapter. The Chapter of the Year award criteria include: Innovation, Education, Outreach and Community Impact. Did you reach your goals this year? Has your Chapter expanded its membership? What has your Chapter engaged in to serve the needs of your local GIS community?

As an added incentive, all Chapters who complete and submit the Chapter Maturity Assessment by the deadline (August 12, 2016) will receive a free registration to the 2016 URISA GIS-Pro Conference (http://www.gis-pro.org). To receive this free registration you must also attend the Chapter Leaders' Forum (CLF) which is held during the conference. We ask all Chapters to send at least one representative from their Board to participate in the Forum - this year it will tentatively be held Wednesday, November 2, 201 from 12:00 Noon-1:30 PM. The Forum gives Chapter leaders an opportunity to share experiences and gain valuable information about Chapter programs and administration. This is a great chance to meet other Chapter Leaders, discuss and share Chapter experiences and issues and to speak directly with the URISA Board of Directors. If there is a specific topic of interest that you would like to have addressed during the Forum, please forward them to me.

 - Collaborate with the Kentucky Association of Mapping Professionals (KAMP) and other groups to conduct at least two workshops during 2016

 - A program for university professors that can provide guidance in how to prepare their students for their professional life. Faculty are often out of touch with the industry.
 - A program that could be offered to non-GIS professionals (school boards, government officials, or businessmen) that will show international support for

- geography literacy at all levels of society. As GIS professionals, we are all responsible for this, but having an international organization providing support at a local level could provide for a better response. This program could be most effective by using examples tailored to the specific professionals attending the programs.
- NextGen 911 and implications for development, maintenance, and integration of GIS databases with emergency dispatch software and systems
- **(C)** Do you have a wish list for URISA International (i.e., areas where your chapter needs assistance, collaborative ideas that would benefit many chapters and URISA International, other)? (3 points)
 - Greater integration between chapters and URISA International would benefit both types of organizations greatly. Essentially create a closer working relationship so that the chapters can still operate somewhat independently, but are more closely aligned as extensions of URISA International. Hopefully, progress with the unified membership model will support better integration and the health of chapters.
 - Being able to utilize URISA International's resources (e.g. Web site hosting, event registration) would provide more opportunities to the local professionals and offerings by Chapters.
 - Provide clearer information of URISA International initiatives (GMI, GISP Exam Prep Work Group) and opportunities for Chapter members to get involved.
- **(D)** What are the three top issues the CAB should be addressing in the coming year? (3 points)
 - Membership: ways for URISA International to help chapters increase and maintain membership numbers and for chapters to promote membership with URISA International.
 - Marketing: promote the sharing of ideas and results amongst URISA International and other chapters as to what marketing strategies have been most effective in terms of membership and events.
 - Engaging Chapter members in initiatives undertaken by URISA International (e.g. GMI)
